# Hooked on the Fishing Clubs of the Poconos RAMBLE THE GROUNDS OF BRODHEAD FOREST & STREAM ON SATURDAY, AUGUST 13

Walks and talks exploring subjects ranging from a local Revolutionary War soldier, to the fishing clubs of the Poconos, to how birds, trees and water work together are on tap at the Brodhead Watershed Association's annual Ramble on Saturday, August 13. This year's Ramble will be all on one site – the beautiful, historic grounds of the Brodhead Forest & Stream Association in Stroud Township. The Ramble starts at 1 p.m. and includes an after-Ramble party with an array of delicious sweet and savory foods and beverages. Tickets for BWA members and non-members who reserve in advance are \$10. For non-members, tickets are \$12 on the day. For children under 14, tickets are \$5 and children under 5, free.

Stations throughout the extensive grounds of the fishing club will be staffed by naturalists, historians, and experts in a wide range of fields, including Don Baylor, Darryl Speicher, and Jim Hartzler. The day's plans include:

- · electrofishing demonstration
- bugs and aquatic insects and why they are important to people
- how forests work with streams to protect drinking water
- how to control invasive plants on stream banks and what to plant in their place
- trout habitat and modifying streams to improve habitat
- how birds, trees, and water work together and benefit people
- the gravesite of a Revolutionary War veteran named Elias Utt
- and culminating in a discussion of the history of fishing in the Poconos by noted local outdoorsman Don Baylor

Wear good walking shoes and bring a lawn chair for the after-Ramble party.

The Brodhead Watershed Association (BWA) is a non-profit environmental organization dedicated to protecting and improving water resources and the environment in the Brodhead and Cherry creek watershed. The BWA assists municipalities, residents,

businesses and groups with protecting natural resources through education, workshops, seminars, public programs, stream monitoring and baseline data collection and stream cleanups.

# Monroe County Transit Authority to Offer Free Transportation for Outdoor Enthusiasts

New this Season, Transit in the Park, Weekends and Holidays, Free Transportation on the Riverview Route and McDade Mover.

From April 30, 2011 through October 30, 2011, Weekends and Holidays, the National Park Service and Monroe County Transportation Authority Pocono Pony are working together to provide transportation to and around the Delaware Water Gap National Recreation area. Service will begin at Crystal St. East Stroudsburg and proceed to locations throughout the park along the McDade Trail. Services will conclude in historic down town Milford.

Pocono Pony bus routes in the park provide access to the many beaches, boat launches and the entire McDade Recreational Trail. Need a canoe or kayak? "Kittatinny Canoes" offer canoe and kayak rentals. Look for their booth across the street from the Dingman's Access. Need a bike?, "Edge of the Woods Outfitters" will offer bike rentals at Smithfield Beach.

If you just want to spend the day out, why not visit the ornate shops of historic downtown Milford and enjoy



lunch at one of the many fine cafes. Access fees to beaches and other designated areas will be waived to people entering via public transportation. The park commission has scheduled many outdoor activities and exhibits. # Daily Water Use Facts How Much Water Do We Use?

- A dairy cow must drink 4 gallons of water to produce one gallon of milk
- 400 gallons of water are used during the growing/production of a chicken.
- 12 gallons of water are used during the growing/production of almonds.
- 13.8 gallons of water are used during the growing/production of a single orange.
- 100 gallons of water are used during the growing/production of a watermelon.
- 150 gallons of water are used during the growing/production of a loaf of bread.
- 3 gallons of water are used during the growing/production of a tomato.
- 120 gallons of water are used during the production of an egg.
- 6 gallons of water are used during the growing/production of French fries.
- It takes approximately one gallon of water to process a quarter pound of hamburger.
- 300 million gallons of water are used to produce a single day's supply of U.S. newsprint.
- It takes 39,090 gallons of water used to manufacture a new car, including tires.

# Your Chance to Help Reduce Mercury in Our Waterways

As you probably know, EPA is holding 3 hearings around the country to take public testimony on their proposed mercury rule. Despite the toxicity of mercury, mercury emissions from coal-fired power plants are unregulated because of decades-long opposition by Big Coal, with the support of many politicians, to any mercury regulations.

Pennsylvania is the 2nd largest emitter of mercury in the nation, and has a state-wide fish consumption advisory for mercury. Over a thousand stream miles and thousands of acres of lakes are contaminated with mercury. For the first time, we may have a chance to reduce the amount of mercury being spewed into the atmosphere. # Fish Kill Hotline Announced 1-855-FISH-KIL

The Pennsylvania Fish and Boat Commission (PFBC) introduced a new toll-free hotline for the public to report suspected pollution incidents or fish kills on April 12.

The number – 1-855-FISH-KIL (1-855-347-4545) – provides the public with a way to quickly alert PFBC staff to suspected environmental incidents, according to Board President William Worobec. "Timely notification is the number one critical factor in dealing with suspected pollution cases and protecting our aquatic resources," he said. "The sooner we know about an incident, the sooner we can evaluate it and, if necessary, implement a response plan. As more time passes



between an incident and our evaluation, we reduce our chances of clearly identifying the source of the suspected pollutant."

Worobec emphasized that the number is to be used only for reporting suspected cases of pollution or fish kills and is not meant for general inquires related to license sales, boat registrations or other agency issues. For more information, please go to:


