## YOU NEED TO KNOW

### Clean Water cleaned up

At last, the Clean Water Act has more clarity.

In 1972, Congress passed the Clean Water Act to protect all "waters of the United States." It is still the primary guard protecting our nation's waters, but by the early 21st century, there were chinks in its armor.

In 2001 and 2006 decisions, the Supreme Court narrowly interpreted the scope of waters covered by the act, weakening safeguards for 20 million wetland acres and two million stream miles.

These unguarded streams made up 60% of the United States' stream miles. Our drinking water, our fish and many wildlife species were at risk for pollution and destruction.

A finalized 2014 rule by the Environmental Protection Agency and the Army Corps of Engineers clarifies the scope of the Clean Water Act, reinforcing the act's legal and scientific foundations while strengthening protection for America's waters.

Now, the Clean Water Act is more precise, more predictably determined, and easier for businesses and industry to understand.

# Clean water: It's your right

Article 1 Section 27 of the Pennsylvania Constitution – Environmental Rights Amendment – guarantees you the right to pure waters:

*"The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustee of these resources, the Commonwealth shall conserve and maintain them for the benefit of all the people."*

**This right to clean air and pure water** is equivalent to the right to free speech.

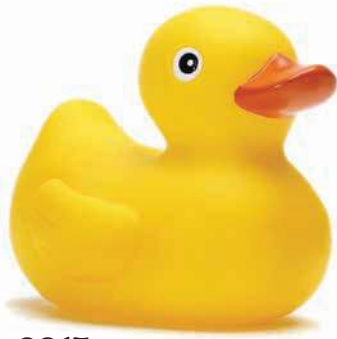
**This amendment, passed in 1971,** was unanimously approved by ALL members of the state Senate and House. A true bipartisan effort.

**The people of Pennsylvania** voted 4-1 in favor of it.

**In 2013, a state Supreme Court ruling** made it clear that every government official in Pennsylvania on every government level had an obligation to protect these environmental rights and to ground their decision on sound science. **Failure to fulfill this obligation opens them to legal attack.**
